OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station KPLX-FM ("Station"), owned and operated by Cumulus Media Holdings Inc. or one of its subsidiary companies, 3090 Olive Street, Suite 400 – Dallas, TX 75219, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **99.5 The Wolf's "Beat the Winter Blues"** Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

- 1. NO PURCHASE IS NECESSARY. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.
- 2. Eligibility. The term "immediate family members" includes spouses, parents and step-parents, siblings and step-siblings, and children and stepchildren. The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions, which are final and binding in all matters related to the Contest. Winning a prize is contingent upon fulfilling all requirements set forth herein.
- 3. Contest Period. The Contest will begin at 12:00am Central Time ("CT") on Monday, January 25, 2016 and will run through 11:59pm CT on Friday, January 29, 2016 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 4. **How to Enter and Win.** Listen to the Station weekdays from 5:00am CT through 10:00am CT during the Contest Period. When the Station plays the "cue-to-call" sounder, listeners should call the Station at 1-888-787-1995. Caller nine (9), or the caller number announced at the time of the contest, to the Station, as determined by the Station in its sole discretion, will have the opportunity to win. Caller nine (9) will have ten (10) seconds, according to the Station's computer, to name five (5) unique things in a specific theme/category as determined by the Station. *Time Delay Between Over-the-Air Analog Signal and Internet Broadcast:* Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.
- 5. Winner Selection. Beginning on January 25, 2016, Station will award one (1) Grand Prize each day during the Contest Period for a maximum of five (5) Grand Prizes to be awarded. Caller nine (9), or the caller number announced at the time of the contest, to the Station, as determined by the Station in its sole discretion, will be the official contestant to have the opportunity to win. The contestant will have ten (10) seconds, according to the Station's computer, to name five (5) unique things in a specific theme/category announced at the time of entry. The Station, and its on-air talent, will be the final judge if all five (5) unique things are in the announced theme/category and clearly stated within the allotted ten (10) seconds. If caller the official contestant is able to name five (5) approved unique things in the announced category within ten (10) seconds, he/she will win the Grand Prize. If the official contestant is unable to name five (5) approved unique things in the announced category within ten (10) seconds, he/she will be disqualified and will not win the Grand Prize and an alternate contestant will be selected to participate. This will continue until a caller is successful. The winning contestant will immediately be notified of winning the Grand Prize and will be contacted using the email address and/or telephone number provided at the time of entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification will result in disqualification.

Some blackout dates may apply. Each trip includes: Roundtrip coach airfare for two (2) on an airline of Impact Marketing & Promotions' choice from the major airport closes to the winner's residence in the Continental U.S. (as determined by Impact Marketing & Promotions' in their sole discretion) to Las Vegas, NV (destination city); double-occupancy standard hotel accommodations for three (3) days/two (2) nights(one room, double occupancy, room rate and tax only) at Luxor Hotel and Casino; one hundred dollars (\$100) in the form of a check or Visa gift card towards ground transportation in destination city; and two (2) tickets to attend a live performance of Blue Man Group with a behind-the-scenes experience at Luxor Hotel and Casino. ARV \$1,950.00. Actual value of the Daily Prize will vary depending on point of departure and the seasonal fluctuation of hotel rates and airfares. Travel dates to be mutually agreed upon by winner and Station. Grand Prize winner and his/her travel companion will be required to travel on the identical itinerary, and are responsible for obtaining identification documents and/or other travel documents required for the trip, as well as for complying with all other legal requirements for travel. Travel companion must be twenty-one (21) years of age or older before the time of travel. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of entrant and Sponsor in connection with the Contest, shall be governed by, and construed in accordance with, the laws of the state in which the Station is located, without giving effect to any choice of law or conflict of law rules (whether of the state in which the Station is located or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the state in which the Station is located.

- 14. Entrant's Personal Information. Information collected from entrants is subject to Station's Privacy Policy, which is available on the Station's website under the "Privacy Policy" link. All entry blanks, forms, devices, and materials gathered during the course of entry, as well as all information contained on or within, shall become the sole property of Station to be used, disposed of or destroyed in its sole discretion. Station is not responsible for any incorrect or inaccurate information entered by website users, and assumes no responsibility for any error, omission, interruption, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to Station's website.
