99.5 THE WOLF'S "DIERKS BENTLEY VIP EXPERIENCE WINNING WEEK" CONTEST OFFICIAL RULES

The Station will conduct the **99.5 The Wolf's "Dierks Bentley VIP Experience Winning Week"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility.
