99.5 THE WOLF'S "LUKE COMBS HOUSTON - KROGER" TEXT CONTEST OFFICIAL RULES

All entries must be received by 11:59pm CT on July 7, 2024 to be eligible for a chance to win a prize. Message and data rates may apply. Station has no responsibility for any fees or charges associated with any text messages entrant sends or receives in connection with the Contest. Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider. Limit one (1) entry per person per phone number.

- 4. **Winner Selection.** On or about 10:00am on July 8, 2024, Station will select seven (7) potential winners in a random drawing from among all valid entries received by Station during the Contest Period.
