99.5 THE WOLF'S "STATE FAIR OF TEXAS WINNING WEEKEND" CONTEST OFFICIAL RULES

The Station will conduct the **99.5 The Wolf's "STATE FAIR OF TEXAS WINNING WEEKEND"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. Each keyword will be announced a minimum of two (2) times on Saturday and a minimum of one (1) time on Sunday during the Contest Period, for a minimum of three (3) times throughout the Contest Period.
