### 99.5 THE WOLF'S "PAPA JOHNS COWBOYS V SAINTS" TEXT CONTEST OFFICIAL RULES

<u>Text</u>: Send a text message with the keyword "PAPA JOHNS" which will be announced each day, the keyword will be announced, and the listener will be given a 15-minute window between 7:00am CT and 10:00am CT each weekday during the Contest Period, to text in the correct spelling of the keyword to 888-787-1995 during the Contest Period. All entries must be received by 10:00am CT on September 8, 2024 to be eligible for a chance to win a prize. Message and data rates may apply. Station has no responsibility for any fees or charges associated with any text messages entrant sends or receives in connection with the Contest. Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider. Limit one (1) entry per person per phone number.

4. **Winner Selection.** On or about 11:00am on September 12, 2024, Station will select one (1) potential winners in a random drawing from among all valid entries received by Station during the Contest Period. Each winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification or

failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.
