99.5 THE WOLF'S "CODY JOHNSON WINNING WEEKEND" CONTEST OFFICIAL RULES

Each keyword will be announced a minimum of two (2) times on Saturday and a minimum of one (1) time on Sunday during the Contest Period, for a minimum of three (3) times throughout the Contest Period.
