99.5 THE WOLF'S "KOE WETZEL WINNING WEEKEND" CONTEST OFFICIAL RULES

The Station will conduct the **99.5 The Wolf's "KOE WETZEL WINNING WEEKEND"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. All entries must be received by 6:59pm CT on October 20 2024, to be eligible for a chance to win a prize. One (1) different keyword will be announced each hour during the Contest Period from 9:00am-9:00pm CT on Saturday and 10:00am-7:00pm CT on Sunday for a total of five (5) different keywords throughout the contest period.

Each keyword will be announced a minimum of two (2) times on Saturday and a minimum of one (1) time on Sunday during the Contest Period, for a minimum of three (3) times throughout the Contest Period. Keywords must be received by the end of the Contest Period to be eligible to participate in the prize drawing. Message and data rates may apply. Station has no responsibility for any fees or charges associated with any text messages entrant sends or receives in connection with the Contest. Each winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of

Failure to respond to the initial verification contact within one (1) day of notification or failure to claim the prize within one (1) day of verification as a winner will result in disqualification and forfeiture of the prize.
