99.5 THE WOLF'S "TWO STEP INN FESTIVAL " TEXT CONTEST OFFICIAL RULES

Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider. Limit one (1) entry per person per phone number.

4. **Winner Selection.** On or about 10:00am on March 31, 2025, Station will select one (1) potential winner in a random drawing from among all valid entries received by Station during the Contest Period. Each winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest.
