NEW COUNTRY 96.3 & 99.5 THE WOLF'S "SECRET CONTEST GEORGE STRAIT- LAS VEGAS FLYAWAY" CONTEST OFFICIAL RULES

The Station will conduct the NEW COUNTRY 96.3 & 99.5 THE WOLF'S "WIN GEORGE STRAIT-LAS VEGAS FLYAWAY" Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. Limit one (1) entry per person per keyword solicit/Contest Round, regardless of how many email addresses a person may possess and use. Multiple participants are not permitted to share the same email address.
