99.5 THE WOLF'S "SNOW WHITE PRIVATE SCREENING" TEXT CONTEST OFFICIAL RULES

- 4. **Winner Selection.** On or about 10:00am CT on Thursday March 13, 2025 Station will select a minimum of one (1) potential winner in a random drawing from among all valid entries received by Station during the Contest Period.
