99.5 THE WOLF'S "STURGILL SIMPSON WINNING WEEK" CONTEST OFFICIAL RULES

The Station will conduct the **99.5 The Wolf's "Sturgill Simpson Winning Week"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. 4. **Text Winner Selection.** On or about 10:00am CT on March 31, 2024, Station will select one (1) potential winner in a random drawing from among all valid entries received by Station during the Contest Period.
